Annual branch meetings

The annual meeting was held at the University of British Columbia in Vancouver, BC, on the traditional, ancestral, and unceded Indigenous territories of the "mə\thetak" ayəm (Musqueam), s\mathbb{k}\w\mathbb{x}\w\mathbb{x}\w\mathbb{x}\wandamin (Squamish), and se\mathbb{i}\in \wandamin \text{intulh} (Tsleil-Waututh) First Nations. Kevin Madill (Local Arrangements Chair) and Marc Stoeckle (Program Chair) organised the meeting. The meeting was held with the Canadian University Music Society (MusCan) and included a program of 11 sessions,, a tour of the Music, Art, and Architecture Library, meetings, and reception. The joint plenary session, given by Eve Poudrier and R\u00e9mi Castonguay, was titled "Music Scholarship and Digital Technologies: Perspectives from Collaborative Corpus Building and Text Analysis." There were 31 individuals in attendance at the meeting.

Branch constitutional matters

During the 2019 Annual General Meeting, a motion was passed to change the CAML Constitution to include the addition of the newly formed Collections Committee.

Branch activities

In November 2018, the Quebec Chapter of CAML held a joint meeting with the New York State-Ontario Chapter (NYS-O) of the Music Library Association (MLA) and the New England Chapter (NEMLA) of MLA. The two-day meeting included about 100 attendees from all three sections and included 16 presentations given by 22 speakers, in addition to poster sessions and a panel presentation by Houman Behzadi (CAML Incoming President), Carolyn Doi (CAML President), Joseph Hafner (IAML Vice-President), Mark McKnight (MLA President) and Susannah Cleveland (MLA President-Elect). A report by Marci Cohen on the meeting was published in a recent issue of CAML Review (vol 46, no. 3,).

Branch publications

The official publication of the Canadian Branch is CAML Review. The journal includes research articles (peer-reviewed), reports, news, essays, and reviews on topics relevant to the Association, particularly those about music in Canada, music librarianship and archival management, and bibliography. Reviews of recordings, books, and reference publications are focused primarily on Canadian content. The journal serves to document the activities of the association, reflect current research and professional activities in the country, and as a resource for a record of publications pertinent to music librarianship in the Canadian context. CAML Review is an open access publication.

There have been three issues of the Review published in the past year. The editorial team included Cathy Martin (Editor), Deborah Wills and Megan Chellew (Associate Editors), and Brian Thompson (Review Editor). The Review is anticipating a significant change in the upcoming year as Cathy Martin and Brian Thompson will be stepping down from the editorial team. The board has issued a call for both positions.

Branch website

Marc Stoeckle (member in good standing) has been volunteering alongside James Mason (Communications Officer) to maintain the branch website. Marc will take over the position of Communications Officer in June 2019, and is working on redesigning the current website. The new design will be unveiled in the upcoming year.

Branch scholarships, grants, bursaries, awards

Margaret Piper (Board Member at Large) was the Chair of the 2019 Awards Committee, and Program Chair Marc Stoeckle and member in good standing Lelland Reed also served as committee members.
