Annual branch meetings

Online meeting via Zoom Friday, June 5, 2020 52 registrants and more than 40 participants at any given session CAML was initially going to meet on June 4 and 5, 2020 as part of the Congress of the Federation for the Humanities and Social Sciences at Western University in London, Ontario. Our Program Chair, Alastair Boyd (Librarian Emeritus, University of Toronto), and Local Organizer, Brian McMillan (Director, Music Library, Western University) had planned a full two-day meeting in conjunction with the Canadian University Music Society (MusCan). Following the university and library closures on March 13, 2020, and in light of the uncertainties caused by the COVID-19 pandemic, the Federation announced its intention to hold an online conference in lieu of the in-person events in London. The Board initially voted in favour of CAML's participation in the online congress, however, the Federation's plans changed when Western University withdrew altogether, an unexpected move that resulted in the cancellation of the online Congress 2020. After much deliberation, CAML decided to postpone its 2020 program to 2021, and to instead hold a one-day free Zoom meeting revolving around the Association's upcoming strategic planning exercise. The meeting also provided opportunities for CAML members to discuss the impacts of the pandemic on the services of music information organizations across Canada.

Branch constitutional matters

Two motions were passed during the 2020 Annual General Meeting (AGM), which took place virtually on June 5:

1) Going forward, CAML can hold virtual AGMs; and 2) CAML can employ online voting platforms compliant with the regulations of federally incorporated associations.

Branch activities

Shortly after the 2019 meeting in Vancouver, CAML President put forward a proposal to the Board to form the CAML Renewal Task Force, a group of three appointed and two elected members who would work with the President towards the release of the Association's Strategic Plan in 2021 during its 50th anniversary meeting. The ultimate goal of the Task Force is to present the membership with several options for the Associations future directions. The process is collaborative and highly consultative, soliciting feedback from the membership through surveys, town halls, and conference sessions. The Task Force members are Houman Behzadi (McGill University, ex officio), Scott Cowan (University of Windsor), Rachel Gagnon (Library and Archives Canada), Jan Guise (University of Toronto), Sean Luyk (University of Alberta), Brian McMillan (Western University). CAML Board welcomed President-Elect Maureen Nevins (Library and Archives Canada) and looks forward to the addition of its new Board Member at Large following the election that is currently underway.

CAML Review is the Association's journal and its main communication tool. Since November 2016, a section of the journal has been dedicated to peer-reviewed research articles.

Both the Lead and the Review Editors stepped down at the end of 2019. Cathy Martin after 10 years of service as Lead Editor, and Brian Thompson after 3 years of service as Review Editor. As a result of these vacancies in the Editorial Board, a call for applications for a new CAML Review Lead Editor and Review Editor went out in the April 2019 issue of CAML Review, again in the December 2019 issue, and was also posted to CANMUS-L. The new Editorial Board consists of Carolyn Doi (University of Saskatchewan), Jan Guise (University of Toronto), Brian McMillan (Western University), Nina Penner (Independent Musicologist), and Jada Watson (University of Ottawa). Both Deborah Wills and Megan Chellew will maintain their roles as Associate Editors.

CAML Review will move from three issues per year to two issues per year (June and December). The Journal's tentative publication schedule is as follows:

- December 2020: Volume 48 "Lost Conference Papers" issue
- June 2021: Volume 49, no. 1 "COVID-19" issue
- December 2021: Volume 49, no. 2 "CAML 50th Anniversary 1971-2021" issue
