Social media activity

Branch educational activity

The Branch delivered their course "Music for the Terrified" to non-music specialist public librarians in Galway.

Branch scholarships, grants, bursaries, awards

The C.B. Oldman prize for an outstanding work of music bibliography, music reference or music librarianship was awarded to Colin Lawson and Robin Stowell, editors of The Cambridge encyclopedia of historical performance in music. (Cambridge: Cambridge University Press, 2018). ISBN 9781107108080.

The E.T. Bryant Memorial Prize for a significant contribution to the literature of music information fields was awarded to Kirsty Morgan (National Library of Scotland) for her dissertation for the degree of MSc at the University of Strathclyde entitled "Linked Data in Small Archives. A case study of the David Fanshawe World Music Archive".

Advocacy and recruitment

The Branch has worked with the Music Libraries Trust to create a survey on music libraries in the UK & Ireland, to inform future plans.

National outreach activities

National copyright issues

Claire Kidwell represented the Branch on the Universities UK Copyright Negotiating and Advisory Committee, which has been negotiating a higher education printed music licence with Printed Music Licensing Limited and the Copyright Licensing Agency over the last few years. Negotiations reached their conclusion in the latter half of the 2019, and a trial licence will be launched to higher education institutions in August 2020.

The Branch responded to the Republic of Ireland's public consultations on the transposition of the EU Directive on copyright in the digital single market. There are aspects of this Directive that will have positive impacts on libraries and their users, and our responses sought to maximize these where there is flexibility in national implementation. It remains to be seen whether the UK will also implement the Directive.
