Elections

Section Meetings

October 2021. The Cataloguing and Metadata Section held business meetings on 14 Oct 1300 UTC and 15 Oct 0100 UTC. The meetings were organized in lieu of the usual meeting at the annual congress, and, to accommodate members across the globe, two sessions were held 12 hours apart. The first session was attended by 13 members from Canada, the Czech Republic, Germany, Greece, Slovakia, the United Kingdom, and the United States, including IAML Board members Jürgen Diet and Rupert Ridgewell; the second session was attended by 5 members from Japan, New Zealand, and the United States. We discussed a range of topics and identified urgent needs that would eventually become the terms of reference of the newly created project group and study group. July 2022. The Cataloguing and Metadata Section held business meetings on 28 and 29 July at the 2022 Congress in Prague. The first session was attended by 8 members from Armenia, Belgium, Greece, Italy, the Netherlands, and the United States; the second session was attended by 15 members from Austria, Germany, Greece, Italy, the Netherlands, Portugal, Slovenia, Spain, the United Kingdom, and the United States. We had lively, free-flowing discussions on a wide range of topics, learned about projects being undertaken in various countries, and identified potential areas of collaboration. Online Event. The online event Cataloguing, Metadata, and Discovery of Digital Music Materials, co-presented by the Broadcast and Orchestra Libraries Section, and the Libraries at Music Teaching Institutions Section, was held in two sessions on 25 March 1300 UTC and 29 March 0100 UTC. The first session had 47 attendees; the second session had 17 attendees. The programme, on issues surrounding acquiring, cataloguing, archiving digital scores and digital AV materials, included the following papers/presenters with ample discussions in between:

- Music Vocabularies in Wikidata. *Christopher Holden (Library of Congress, USA)*

Michelle Hahn, Chuck Peters, and Chris Holden presented live in both sessions; Valeria Luti presented a pre-recorded video in both sessions; Maria Aslanidi presented live in the first session, and the recording of the first session was played in the second session.
