### **Branch constitutional matters**

At the AGM Mark Hector from the National Library of New Zealand was elected to the executive committee.

Michael Brown stepped down from the Secretarial role at the AGM, the role of which is currently shared amongst committee members.

The New Zealand Government is introducing new rules for Incorporated Societies. The necessary changes are minimal for IAML(NZ) so work is underway to make alterations to our constitution.

#### **Branch activities**

#### 2024 Conference

Our annual conference began at the Victoria University Law School in Wellington on Thursday 7 Nov 2024 with sessions on intriguing topics such as aspects of collecting from a private collector, tracing the origins and development of Maori and Moriori instruments, a NZ internet-based record label *Crystal Magic Records* and Updates on the Utaina digitisation project.

We finished the day with a visit to the New Zealand Symphony Orchestra Library followed by the conference dinner.

On the second day we moved to the National Library for the AGM followed by a talk on how Record stores deal with problematic material, and a presentation on Wellington Public Library's experiences setting up a CD play and PA hire service.

# **Branch projects**

We have started the process for a collaborative digitisation project, through the National Library, of a significant NZ publication called *The Triad* which was running from 1890s through to 1927. This will be a long term project as it is quite a complex undertaking requiring collaboration with several institutions.

National Library and National Archives are undergoing significant organizational change at present. In December, IAML was privileged to respond to their consultation document where we advocated for the continued excellent service delivery and access to collections for our music community to be maintained and strengthened.

# National copyright issues

Copyright: IAML NZ is keeping a watching brief on current government reviews of the NZ Copyright Act. The government intends to extend the copyright term to 70 years by 2026.

### **RILM and RISM contributions**

Erika Arthur remains as chair of the small RILM committee. Most of the entries are now for monographs and theses, with the small number of printed issues of NZ music journals now being published.

In January 2025, RILM's Executive Director, Tina Frühauf, and Executive Editor, Zdravko Blažeković visited the National Library of New Zealand in Wellington.
