

## IAML Cataloguing and Metadata Section - Annual Report 2021

In 2020, the UNIMARC code lists for musical forms (bibliographic field 128) and medium of performance (bibliographic field 146) were migrated from a relational database to the new UNIMARC vocabularies namespace on the IFLA Standards website: <a href="https://www.iflastandards.info/unimarc/terms/fom">https://www.iflastandards.info/unimarc/terms/fom</a> and <a href="https://www.iflastandards.info/unimarc/terms/mop">https://www.iflastandards.info/unimarc/terms/mop</a>. We would like to thank Massimo Gentili-Tedeschi (Ufficio Ricerca Fondi Musicali, Milan, Italy) for many years of development and maintenance of the relational database.
