

### STUDY FINDINGS - PUBLISHING

"OA helps to bridge the divide between academic and independent researchers."

"I know a colleague who refuses to publish in gated journals, and I think it's slowed his career a bit."

### STUDY FINDINGS - PUBLISHING

"[T&P] forces a self-focused attitude toward advancement and putting lines on your resume is more productoriented than impactoriented. OA won't stick until it becomes a requirement in T&P process."

"I think everyone is in favor of OA, we just don't know how to implement [it]." "Textbooks are expensive, one size fits all, conservative, more about content than critical thinking, and you can't change them."

"I use publisher
textbooks because
 the OA ones
 aren't good."

### STUDY FINDINGS - TEACHING

"We need more discussions in AMS and SAM about this. How can we get better resources [and] credit ... for doing this work?" "[It is] hard to find good OA sources on some topics. I have to write my own sometimes even though I'm not the best person to do it."
